### **Fitness Centers**

The Frank Brown Recreation and Boykin Community Fitness Centers are open to citizens who live or work within the city limits of Auburn, AL. A \$25.00 fee will be charged for a membership card and replacement cards will also cost \$25.00. The membership card is non-transferable and can only be used by the card holder. Children ages 16-18 years must be accompanied by a parent or legal guardian while using the fitness center; anyone under the age of 16 is not allowed membership.

### **eSports Room**

The eSports room at Frank Brown Recreation Center is open to citizens who live, work or attend school within the city limits of Auburn, AL. A membership must be acquired for the eSports room. There is no initial cost for an eSports room membership card, however, replacement cards will cost \$25.00. The membership card is non-transferable and can only be used by the card holder. Children age 12 and under must be accompanied by an adult while using the eSports room and both the child and the parent/guardian must have a membership card.

### **Free Play Basketball & Racquetball**

Free play basketball and racquetball at Frank Brown Recreation Center are open free of charge to citizens who live, work or attend school within the city limits of Auburn, AL and to non-citizens for a one-time \$25.00 fee. A membership must be acquired for free play basketball and racquetball regardless of age. Replacement cards will cost \$25.00 regardless of residency. The membership card is non-transferable and can only be used by the card holder. You must be at least 13 years of age to participate in free play basketball and 15 years of age to participate in racquetball. Children ages 13-18 must have a waiver signed by a parent/guardian at the time of application.

### **Proof of Residency – Age 19 and Above**

An item from List A and List B must be presented in order for a patron to acquire a membership card. Any combination is acceptable as long as there is one item from List A and one item from List B. Current is defined as within the last 60 days.

## **Frank Brown Recreation Center & Boykin Community Fitness Center Rules**

1. The use of the fitness center is non-transferable and can only be used by the card holder.
2. Children ages 16-18 years must be accompanied by a parent or legal guardian; anyone under the age of 16 is not allowed membership.
3. Patrons must wipe off equipment after each use.
4. Appropriate athletic wear (mesh shorts, T-shirts, tank tops, warm-ups, sweats, etc.) is recommended. Shirts that fully cover the chest and back must be worn in the facility.
5. Appropriate footwear is required. Sandals or open toe shoes are prohibited.
6. The Fitness Center is designated as a "Cell Phone Free" Zone. Sound equipment, such as iPods, CD players, Cell Phones, etc. are allowed with the use of headphones or ear buds.
7. Food, gum, or tobacco products are prohibited.
8. No open beverages or glass containers. Only closed bottles containing water or sports drinks are allowed.
9. Please limit the use of cardiovascular machines to 30 minutes when others are waiting.
10. Anyone operating equipment in an unsafe manner will be asked to leave. Excessive dropping or slamming weights is prohibited.
11. Patron may be billed for damaged equipment.
12. Please ask the Fitness Center Attendant on duty for assistance on how to use the equipment.
13. Report any damaged equipment, accidents or misconduct to the Fitness Center Attendant or Center staff.
14. All patrons may use day-use lockers, but contents and locks must be removed on a daily basis. Locks will be cut off or lockers opened and contents will be cleared at the end of each day.
15. Frank Brown Recreation Center staff are not responsible for lost or stolen items.
16. Profanity or inappropriate behavior will not be tolerated.
17. Patrons are not allowed to remove weights from any of the Fitness areas.

All rules and regulations pertaining to the use of the facility as established by the City of Auburn, AL Parks and Recreation Department will be strictly enforced. We reserve the right to deny entry to anyone displaying inappropriate behavior, including belligerence or intoxication. Refusal to follow the policies of the Frank Brown Recreation Center and Boykin Community Fitness Center may result in removal from the facility.

## **Frank Brown Recreation Center eSports Room Rules and Expectations**

1. To play, all players/participants must check-in at the front desk. A valid membership card must be presented to staff to enter the room. No one is allowed into the room without a valid membership card. Anyone who allows someone in the room without a valid membership card is subject to suspension.
2. Gaming station use is limited to 1.5 hours. If there is no one waiting to use the station, time may be extended.
3. Food and beverages are NOT allowed in the eSports Room.
4. Do not sit or lean on gaming station counters.
5. Behaviors that create a toxic environment such as harassment, sexual misconduct, discrimination, bullying, threats of violence, stalking, or other forms of intimidation (either online or in-person) will not be tolerated. No cheating, profanity or inappropriate language/gestures.
6. Out of respect for other users, individuals must limit their game and personal volume to a level deemed appropriate by staff.
7. Smoking, vaping, and other tobacco products are prohibited.
8. Personal items must be kept in your possession at all times. Auburn Parks & Recreation is not responsible for lost or damaged personal items.
9. Gambling is not allowed; betting, and/or playing for money or other things of value is absolutely prohibited. Money matches are strictly prohibited.
10. Users will only have access to the specific games available on the consoles.
11. A gaming controller is provided at each station. Players may use their own headset and can bring their own controller if preferred.
12. Players must report damaged or malfunctioning equipment prior to use.
13. Damage of the equipment or failure to follow the posted rules may result in fines and/or other actions, such as suspensions.
14. Area is under video surveillance.
15. While the eSports Room is a fun and competitive space, there will also be times in which classes or events may be held in the rooms surrounding the space. Users who do not decrease the noise levels upon request will be required to leave the eSports Room.
16. All games played in the eSports Room must be rated T for Teen or below by the Entertainment Software Rating Board unless approved for an 'adult only' playing period/tournament.

All rules and regulations pertaining to the use of the eSports Room as established by the City of Auburn, AL Parks and Recreation Department will be strictly enforced. We reserve the right to deny entry to anyone displaying inappropriate behavior, including belligerence or intoxication. Refusal to follow the policies of the eSports Room may result in removal from the facility.

## Frank Brown Recreation Center Free Play Basketball Rules

1. All patrons must have a membership card and check-in at the front desk.
2. Report any concerns to staff at the front desk.
3. Gymnasium closes 15 minutes prior to the building closing.
4. Must wear shirt and appropriate basketball shoes at all times (athletic shoes, no black soles).
5. No food or drink in the gym. Water in a sealed bottle is allowed (no cups).
6. No dunking or hanging on the rims.
7. Foul language, fighting and other obscenities are strictly prohibited. No trash talk.
8. Children 12 years old and under must be accompanied by an adult at all times.
9. Basketballs are not to be dribbled anywhere in the building except for the gymnasium.
10. Music will not be allowed.
11. All checked-out equipment is for indoor use only.
12. Put all trash and recyclables in proper container.
13. The City of Auburn, AL is not responsible for personal items left unattended, lost or misplaced.
14. Report any accidents or incidents to front office staff immediately.
15. Must follow age guidelines below:

### Age Key for Basketball Gymnasium

Family: Children 12 years and under with parent/guardian.

Teen: Ages 13 – 18

Adult: 19+

Open Gym: All Ages

## **Frank Brown Recreation Center Racquetball Court Rules**

1. All patrons must have a membership card and check-in at the front desk.
2. Report any concerns to staff at the front desk.
3. Walk-ins are welcome, but reservations are recommended. Reservations can be made up to 24 hours in advance by calling 334-501-2962.
4. Reservations may be held for 15 minutes past the scheduled time, after that the court will be given out on the first-come, first-serve basis.
5. All players must wear non-marking, rubber-soled athletic shoes.
6. Racquets, balls and goggles are available for check-out at the front desk.
7. Children under 15 years old will not be permitted on the racquetball court.
8. All trash and recyclables must be put in proper container.
9. The City of Auburn, Alabama is not responsible for personal items left unattended, lost or misplaced.
